Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

**A9** Information gathering,

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information analysis, and dissemination (including, but not limited to, document publication and distribution, and classroom training and dissemination informational programs), but not including site characterization or environmental monitoring. B3.6 Smallscale **laboratory** operations, and pilot projects

Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and research and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a development, concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

### Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to the University of Central Florida (UCF) for computational and experimental efforts to improve supercritical carbon dioxide (sCO2) compressor operations under various inlet conditions. Testing activities would be performed in the sCO2 Flow and Heat Transfer Laboratory at UCF. Computation and design work would occur at CRAFT Tech's facility in Pennsylvania.

Project activities would include study of the detailed flow behavior inside a compressor cascade under various compressor inlet conditions, design of improved compressor airfoils, and validation of the design by testing in a compressor cascade rig. Project work would occur within existing dedicated facilities designed for this type of work and would utilize standard equipment. No facility modifications, new permits, additional licenses and/or authorizations would be necessary. No ground disturbing activities, no changes in operation of existing facilities, and no installation of equipment outdoors would occur for project activities. The project would involve the use of carbon dioxide at room temperature and high pressure. The laboratory has established standard operating procedures in place for handling carbon dioxide at these temperatures and pressures. All activities would comply with Federal, state, and local environmental regulations. DOE does not anticipate any impacts to resources of concern due to the proposed activities.
