Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

**A9** Information gathering,

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information analysis, and dissemination (including, but not limited to, document publication and distribution, and classroom training and dissemination informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

B3.6 Smallscale **laboratory** operations, and pilot projects

Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and research and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a development, concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Outdoor tests and experiments for the development, quality assurance, or reliability of materials and Outdoor tests equipment (including, but not limited to, weapon system components) under controlled conditions. Covered actions include, but are not limited to, burn tests (such as tests of electric cable fire resistance or the combustion characteristics of fuels), impact tests (such as pneumatic ejector tests using earthen embankments or concrete slabs designated and routinely used for that purpose), or drop, puncture, waterimmersion, or thermal tests. Covered actions would not involve source, special nuclear, or byproduct materials, except encapsulated sources manufactured to applicable standards that contain source, special nuclear, or byproduct materials may be used for nondestructive actions such as detector/sensor development and testing and first responder field training.

#### Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to RE2, Inc. to develop an autonomous robotic system for efficiently transporting and mounting solar photovoltaic (PV) modules. Once all the necessary prototype components are developed and integrated, the complete system would be validated first within a laboratory environment and then within an operationally relevant environment.

Activities associated with the proposed project include the design, development, fabrication, testing, and field validation of an autonomous robotic system and its various components. Design, development, fabrication, and testing activities would occur at the RE2 research and development (R&D) facility in Pittsburgh, PA. Fabrication activities would require the machining of some metals. It is estimated that the project would use less than 100 lbs. worth of such material in total. Scrap metal generated from the machining of components is not anticipated to exceed 5 lbs. and would be recycled.

A portion of solar racking equipment would be installed in RE2's outdoor test space for the purposes of prototype testing, which would require that solar mounting piles be driven into to the ground with a vibratory hammer. Upon conclusion of testing these piles would be removed from the ground. Currently this site is a fenced-in area dedicated to robotics testing; all ground disturbing activities would be conducted entirely on land that has been previously disturbed.

Field work would occur at existing solar construction sites operated by project partner M. A. Mortenson Company. Baseline data would first be collected and analyzed at a Mortenson site in Guy, TX. Final system validation would be conducted at a Mortenson site in Minneapolis, MN. All equipment installations would be temporary and removed at the conclusion of the proposed project.

The facilities at which project work would occur were designed for the type of activities being proposed; therefore, no adverse impacts to sensitive resources are expected as a result of project activities at any location. No change in the use, mission or operation of existing facilities would arise out of this effort. No modifications or new permits, additional licenses and/or authorizations would be required.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
