Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and dissemination informational programs), but not including site characterization or environmental monitoring. Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to the National Center for Appropriate Technology to develop a web-based clearinghouse of agrivoltaic information, termed the Agri-Solar Clearinghouse. This clearinghouse would serve as an information-sharing, relationship-building, public communications hub, and professional network for the practice of co-locating agriculture and solar development.

The types of activities associated with the proposed project would be limited to outreach, training, education, stakeholder engagement, and website development. The Recipient also plans to conduct approximately 20 field trips to "Solar+Aq" sites for the purpose of facilitating visual and hands-on learning and would produce video and photographic content. There would be no interaction with or disturbance of land or the surrounding environment during the field trips. No change in the use, mission or operation of existing facilities would arise out of this effort.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
