Proposed Action Title: Solicitation on Topics Informing New Program Areas Funding Opportunity Announcement (FOA), Topic P: "Direct Removal of Carbon Dioxide from Ambient Air" (DAC & DAC SBIR/STTR) (FOA Nos. DE-FOA-0001953 & DE-FOA-0001954) Programs

Proposed Action Description:

The DAC Program seeks to support the establishment of robust, energy efficient, and low-cost strategies for direct removal of carbon dioxide from ambient air. Specifically, DAC projects will develop novel capture materials, components, and full system designs that enable direct air capture systems with the potential to lower capital and operating expenditures, and to scale to Gt-levels of CO₂ capture. If successful, DAC projects will enable full systems to achieve a Levelized Cost of Capture <\$100/t CO₂; Second Law Efficiency >30%; and Embodied Emissions <5%.

The DAC Program is composed of 3 small-scale research and development projects that will be conducted by universities, non-profit entities, for-profit entities, and federal laboratories. This Determination covers all 3 projects (listed in Attachment A). All 3 projects fit within the class of actions identified under the DOE Categorical Exclusion identified below and do not involve any extraordinary circumstances that may affect the significance of the environmental effects of the projects. This assessment was based on a review of the proposed scope of work and the potential environmental impacts of each project. All project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and Local regulatory requirements.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
