Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Rationale for determination:

The Department of Energy (DOE) is proposing to issue a Funding Opportunity Announcement (DE-FOA-0002452) that would lead to the selection of up to 35 U.S. colleges or universities. These schools would be designated "Industrial Assessment Centers" (IACs). The IAC program is a manufacturing efficiency and workforce development initiative of DOE's Advanced Manufacturing Office based in the engineering departments of colleges and universities nationwide.

The selected IACs would train at least 10 students (graduate and undergraduate) annually, issue certificates of achievement to at least 5 students annually, and conduct approximately 20 assessments for small to medium-sized enterprises (SMEs). At least 10% of the assessments would be completed at wastewater treatment and water resource recovery facilities. The assessments would focus on areas of energy and water savings, waste reduction and productivity improvements. Additionally, cybersecurity screenings, identification of smart manufacturing, decarbonization and electrification opportunities, and resiliency planning would also be completed with the assessments. Upon completion of the assessments, recommendations would be reported to the SMEs together with estimates of the energy savings, implementation costs, and payback periods.

Anticipated activities under this FOA would include education and outreach efforts, data analysis, computer modeling, and technical assistance, along with reporting and program management activities.

NEPA PROVISION

DOE has made a final NEPA determination.

This NEPA Determination applies to the issuance of the FOA as well as all awards selected under the FOA, provided the scope of the selected awards remains consistent with the intent of the FOA as currently described.
