Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to Clean Energy States Alliance, Inc. to undertake studies relating to solar knowledge, community knowledge, and perspectives on solar energy in order to improve the number of community-based solar projects in low-to-moderate income (LMI) communities. The project team would engage community-based organizations (CBOs) and state energy agencies (SEAs) and provide the knowledge and information needed to improve their ability to develop solar energy in LMI communities. Information would be gathered through workshops, interviews, and case studies of community-based solar projects that included state program support and active CBO involvement. Project materials, findings, and recommendations would be disseminated to stakeholders through outreach including webinars, blogs, emails, and social media and combined into a comprehensive report that would include overall recommendations for SEAs, CBOs, and other solar stakeholders.

The proposed project would consist solely of intellectual, academic, and/or analytical activities. All project activities would be conducted from existing offices or computational facilities and use no materials beyond basic office supplies, software, and computer hardware.
