SECOND AMENDED NEPA DETERMINATION: (See attached original and First Amended Determinations, dated February 6, 2017 & September 18, 2018, respectively)

This Second Amended Determination follows changes to the project team and milestones and the approval of additional funds to support the project team's small-scale, research and development activities to test the 10 MVA unified power flow controller (UPFC) prototype at the NREL facility. Specifically, the project team will continue transferring and debugging the developmental software code from the low voltage test rig to the prototype to ensure safe operation at the NREL facility and complete field installation and testing. If successful, the project team will test and certify the 10 MVA unit at NREL, enabling it to conduct field testing necessary for successful commercialization of the unit.

Project activities will be conducted at existing facilities listed in Attachment A designed for the applicable activities. Project tasks continue to fit within the class of actions identified under the DOE Categorical Exclusion identified below and do not involve any extraordinary circumstances that may affect the significance of the environmental effects of the project. This assessment was based on a review of the proposed scope of work and the potential environmental impact of the project. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
