Proposed Action Title: University of Southern California -- STEAM: System Testbed, Evaluation, and Architecture Metrics

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Arlington, VA; Marina del Rey, CA; Los Angeles, CA

Proposed Action Description:

Funding will support the project team's information gathering and analysis efforts to develop a framework and testbed for evaluating the potential of proposed photonic and optoelectronic technologies to reduce overall power consumption in datacenters. Specifically, the project team will: (1) provide system-level modeling and simulation services to facilitate technology transition to ENLITENED teams for both commercial datacenter and HPC environments; (2) incorporate new hardware into the STEAM testbed; and (3) develop common workloads, metrics, and benchmarks to demonstrate the potential of ENLITENED technologies. If successful, the project team will provide active modeling and simulation support for ENLITENED performers, with support tailored to performer needs. The team will also deliver final quantitative benchmark results using program metrics to show potential of ENLITENED-enabled architectures, including opportunities for improvement on future system architectures.

Project activities will be conducted at existing facilities at University of Southern California (Los Angeles, CA; Marina del Ray, CA, and Arlington, VA). The proposed project activities under this award are limited exclusively to intellectual, academic, or analytical activities. The project team will not conduct physical experiments, prototype fabrication, demonstration projects, or similar activities under this award.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
