On December 3, 2021, Venture Global Calcasieu Pass ("Calcasieu Pass") submitted for filing its Application for Limited Amendment to its Existing Long-Term, Multi-Contract Authorizations to Export Liquefied Natural Gas to Free Trade and Non-Free Trade Agreement Nations ("Amendment") in FE Docket Nos. 13-69-LNG, 14-88-LNG, and 15-25-LNG.

Subsequent to the submission of the December 3, 2021 Amendment, Calcasieu Pass realized that a correction is needed in footnote 7 of the Amendment. Specifically, the reference to 40.666 Bcf/yr in the last sentence of footnote 7 should be replaced with 20.666 Bcf/yr, consistent with the increase in authorized export volumes requested in the Amendment. Similarly, the reference to 173.466 Bcf/yr in the first sentence of footnote 7 should be replaced with 153.466 Bcf/yr.

Calcasieu Pass regrets any confusion caused by this error and respectfully requests that these corrections be incorporated into the Amendment.
