Registration of Entity to Export LNG

Dear Ms. Sweeney:

In the Department of Energy ("DOE"), Office of Fossil Energy's ("FE") Order No. 3019 issued October 7, 2015 (as amended), and in Order No. 3331-A issued on May 7, 2015 (as amended), in the above referenced dockets, Cove Point LNG, LP ("CPL") was granted long-term authority to export liquefied natural gas (LNG) (1) to nations with whom the United States has entered into a free trade agreement requiring the national treatment of natural gas; and (2) to non-free-trade-agreement nations. The orders permit CPL to use its authorizations to export LNG as an agent for other entities after registering the other parties with DOE/FE.

CPL now submits the information necessary to register BP Energy Company ("BPEC") as an entity for which CPL will utilize its authorizations to export LNG, in accordance with the terms of DOE/FE Order No. 3331-A and Order No. 3019. Additional information required for the registration of BPEC is included in the letter from BPEC to Cove Point dated June 10, 2022, attached as Attachment A.
