Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. A11 Technical advice and assistance to organizations Technical advice and planning assistance to international, national, state, and local organizations.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to two awards through the SolSmart Program Management Funding Opportunity Announcement (DE-FOA-0002513). SolSmart is a national community designation program that recognizes communities for making it easier and faster to install solar energy. Federal funding is not awarded directly to local governments; rather, local governments that qualify for recognition receive a prominent national designation and join a peer network of leading communities across the country. The program provides local governments with technical assistance (TA) to improve their permitting, inspection, and zoning processes, and take other steps to reduce soft costs.

The SolSmart Program would be implemented by The Interstate Renewable Energy Council (IREC; award number DE-EE0009951) and the International City/County Management Association (ICMA; award number DE-EE0009950). IREC would be responsible for managing the designation review program and would create and launch a new user platform to be used by TA providers, designation reviewers, and communities. The platform would serve as a single repository of all SolSmart program activities and resources. ICMA would provide overall management of the TA program. They would manage a team of TA providers, orchestrate TA assignments and workflow, and organize staff trainings.

Activities funded through the SolSmart Program Management FOA would be limited to administrative activities and technical assistance. Completion of the proposed projects would require no resources beyond basic office supplies, computers, and software. This NEPA determination applies to both DE-EE0009950 and DE-EE0009951.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. To fit within the classes of actions listed in 10 CFR Part 1021, Subpart D, Appendix B, a proposal must be one that would not: (1) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; (2) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; (3) disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; (4) have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of 10 CFR Part 1021, Subpart D, Appendix B; (5) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements, such as those listed in paragraph B(5) of 10 CFR Part 1021, Subpart D, Appendix B.

There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
