Proposed Action Title: University of California, Berkeley -- Mesh Network of Soil Sensors for Greenhouse Gas Monitoring of Biofuel Agriculture

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Berkeley, California; Boulder, Colorado

Proposed Action Description:

Funding will support the project team's small-scale research and development of a wireless "SmartStake" technology consisting of low-cost consumable sensor arrays to measure nitrous oxide (N₂O) concentrations and other drivers of emissions (ammonium, nitrate, oxygen, moisture, temperature, pH, and denitrification enzymes) in agricultural fields. Specifically, the project team will design, test, and deploy a printed sensor array and wireless communication platform for quantifying N₂O emissions and the associated drivers in biofuel crop soils. If successful, this project will result in SmartStake technology to quantify, monitor, and manage N₂O emissions from biofuel agriculture, and provide real time data to farmers on water and nutrient concentrations that will improve efficiency and lower fertilizer costs.

Project activities will be conducted at existing facilities at University of California, Berkeley (Berkeley, CA) and University of Colorado (Boulder, CO), designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
