Project Title: Transfer of Effluent from HP-50 to ETP

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken/South Carolina

Proposed Action or Project Description:

During routine sampling of HP-50 on 03/19/2022 by Savannah River Tritium Enterprise (SRTE), the pH of the effluent was identified as significantly lower than normal. Site Services installed a bladder pipe plug downstream of HP-50 and are currently holding an estimated 10,000 gallons of water upstream of the H-12 outfall. This water exceeds the ETP wastewater collection tank (WWCT) limits for nitrates, although it is within the pH range of 1-12.5 and below the aluminum concentration limit of 892 mg/L. A special waste compliance plan is being developed for transfer of this wastewater to ETP. The water will be transferred to a tanker trailer in 5,000 gallon batches where it will be sampled. ETP Engineering will approve each individual batch after sample results are received from the Liquid Waste Generator Representative (LWGR), allowing the water to be transferred to ETP via process sewer manhole 44A. Revision 0 of this EEC ONLY includes transfer of the effluent to the tanker trailer and sample collection/analysis.

- There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or § 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
