Description:

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to [Northeastern University](#) to design a curriculum and software to train building operators on grid-interactive buildings and occupant-centric controls, and conduct trial training sessions to measure the curriculum's efficiency.

This award would be executed in three budget periods (BPs). Award activities include development of a 14-hour training curriculum and software development of a Building Operation Emulator (BOEm) to provide trainees with simulations used to teach building automation system fundamentals. Trial training sessions would be held with instructors and students to obtain feedback and demonstrate the effectiveness of the curriculum.

All facilities are preexisting purpose-built facilities for the type of work to be conducted for this award. Facility modifications would not be required.

**FOR CATEGORICAL EXCLUSION DETERMINATIONS**

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. environment and conducted in accordance with applicable requirements, such as those listed in paragraph B(5) of 10 CFR Part 1021, Subpart D, Appendix B.

There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
