Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

## Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to CalWave Power Technologies, Inc. (CalWave) to fabricate and deploy a wave energy converter (WEC). The WEC would be deployed at the PacWave South test site off the coast of Oregon.

This NEPA determination does not apply to Budget Period (BP) 2 activities. Some BP2 details are not fully defined and are contingent on outcomes of BP1 activities. DOE will complete the NEPA review for BP2 when sufficient information is available to conduct a meaningful review.

BP1 activities would include project planning activities to prepare for WEC fabrication and deployment. Activities would include: literature review, planning, data analysis, computer modeling, document preparation, coordination with partners, establishing contracts, and ensuring compliance with regulations and other requirements. BP1 activities would not include fabrication or deployment activities.

CalWave would negotiate with federally funded research and development centers (FFRDCs) to participate in award activities. Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

DOE has considered potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate adverse impacts on these resources.
