Project Title: Dismantle and Remove Soil Vapor Extraction Equipment from the A-Area Miscellaneous Rubble Pile (731-6A) Operable Unit

Program or Field Office: Savannah River Site

Proposed Action or Project Description:

The U.S. Department of Energy, U.S. Environmental Protection Agency, and South Carolina Department of Health and Environmental Control agreed that the passive soil vapor extraction (SVE) system (i.e., MicroBlowers™) at the A-Area Miscellaneous Rubble Pile (731-6A) could be permanently shut down. Therefore, Savannah River Site will dismantle and remove the existing SVE equipment from the A-Area Miscellaneous Rubble Pile (731-6A) Operable Unit. The existing electrical equipment will be re-used by Site Services. The nineteen (19) MicroBlowers™ have been saved for re-use by Area Completion Projects. The SVE wells will be abandoned.
