Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to authorize the administration of a prize competition, known as the "H-Prize: Hydrogen Shot Incubator" (Prize), designed to solicit multidisciplinary contributions to identify, develop, and test technologies that would reduce the cost of clean hydrogen production. In support of DOE's Hydrogen Energy Earthshot initiative, the competition would be comprised of two phases (Propose! & Prove!), each offering a cash prize for select participants. The competition would be administered by DOE and the National Renewable Energy Laboratory (NREL). NREL directs and administers the DOE-funded American-Made Network prize competitions, responsible for helping competitors utilize national laboratory resources. Through the proposed Prize, DOE would progressively award federal funding in the form of cash prizes and vouchers to competitors.

For this prize competition, competitors would be tasked to present innovative pre-commercial technology with the potential to produce clean hydrogen with the goal cost of \$1/kg. This would include decarbonization, chemical production, energy storage, and transportation technologies that would reduce current clean hydrogen costs. Specific competitors are unknown at this time.

Up to 10 competitors from the Propose! phase would be selected to receive \$10,000 cash and \$50,000 vouchers to collaborate with national laboratories. All activities in the Propose! phase would be of an intellectual, academic, and analytical nature. Activities would include data analysis, computer modeling, and document preparation. Only those competitors selected in the Propose! phase would be eligible for the Prove! phase where they would further develop their concepts into laboratory demonstrations. This NEPA determination reviews activities associated with the Propose! phase of the Prize only.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.
