Project Title: Install Interpretive Sign at Pre-Schooner II, Idaho, Site

Location: Pre-Schooner II, Idaho, Site

Proposed Action or Project Description:

LM proposes to install an interpretive sign at the Pre-Schooner II, Idaho, Site. The sign would provide historical context to visitors at the site. The Legacy Management Support contractor would install the sign near the existing fence line in a previously disturbed area; the sign would be approximately 2 × 3 feet. Holes for the posts would be hand-dug and filled with concrete. The sign would be designed in a way that prevents birds of prey from nesting on it. The proposed work is scheduled for August–September 2022. The site is on land managed by the U.S. Bureau of Land Management (BLM). BLM permits and rights-of way are required before work begins. The permitting process includes an environmental evaluation that is performed by BLM.
