Proposed Action Title: Sublime Systems -- Electrochemical Upcycling for Low-CO2 Materials Production

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Somerville, Massachusetts; Cambridge, Massachusetts

Proposed Action Description:

Funding will support the project team's small-scale research and development of a platform technology that uses electrochemistry to upcycle waste products and low-value minerals into valuable, carbon dioxide- (CO₂) neutral materials, while using renewable energy to power the electrochemical reactor. Specifically, the project team will (1) develop and test an impurity-tolerant electrochemical reactor for use in chemical (acids and bases) materials processing, (2) develop and test chemical processing steps of the produced materials aimed at separating, extracting, and purifying the chemical elements, and (3) produce CO₂-neutral products, such as metals and cement. If successful, the project will produce useful materials from low-value waste products, reduce environmental contamination, decrease greenhouse gas emissions, and reduce extraction and use of raw materials.

Project activities will be conducted at existing facilities at Sublime Systems (Somerville, MA) and Massachusetts Institute of Technology (Cambridge, MA) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
