Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to the Pueblo of Laguna to install rooftop solar photovoltaic (PV) systems on four community centers on Pueblo of Laguna tribal lands in New Mexico.

Award activities include installing solar PV panels on the roofs of the community centers in the villages of Mesita, Pagate, Paraje, and Seama. Other activities would include supporting electrical work, project management, and training tribal members on installation, operation, and maintenance of the system. No ground disturbance would result from this award.

Project activities would involve hazards associated with working with electricity, power tools and working at heights. Any risks or hazards would be mitigated through established Tribal safety and construction protocols. The Pueblo of Laguna would observe all applicable health, safety, and environmental regulations. DOE does not anticipate any impacts to resources of concern due to the proposed activities of the project.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. To fit within the classes of actions listed in 10 CFR Part 1021, Subpart D, Appendix B, a proposal must be one that would not: (1) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; (2) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; (3) disturb hazardous

There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
