Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to the Paskenta Band of Nomlaki Indians to install two roof-mounted solar photovoltaic (PV) systems on their newly constructed Community Center. PV arrays are being installed in order to reduce electricity costs, support economic development, and enhance energy self-determination and sustainability.

Award activities would include the finalization of plans, structural assessments, permitting, and site preparation. PV panels would be installed on the roof of the Community Center and would provide electricity for both the Community Center and adjacent Administration Building. Twenty yards of underground conduit and wiring would connect the new PV systems to the existing buildings' electrical systems.

Physical modifications of existing structures and ground disturbing activities include installing roof-mounted PV panels and underground wiring. The area is previously disturbed from the recent construction of the Community Center and Administration Building. A Permission to Operate (PTO) would be obtained from the Pacific Gas and Electric Company (PGE). DOE does not anticipate any impacts to resources of concern due to the proposed activities of the project.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. To fit within the classes of actions listed in 10 CFR Part 1021, Subpart D, Appendix B, a proposal must be one that would not: (1) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; (2) require siting and

There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
