Proposed Action Title: Advanced Ionics, Inc. -- Simplified Steam Electrolysis: Hydrogen for Hard-to-Abate Industries

Program or Field Office: Advanced Research Projects Agency - Energy

Proposed Action Description:

Funding will support the project team's small-scale research and development of a high-efficiency, low-cost, hydrogen electrolyzer technology for future gigawatt-scale hydrogen production. Specifically, the project team will (1) model and design electrolyzer technology, (2) develop and test electrolyzer functions, and (3) develop, test, and evaluate final system design. If successful, this project will result in a system that will enable and catalyze decarbonization in biorefining, ammonia production, chemical production, steel, glass, methanol, and other high-consumption industries that currently rely on steam methane reforming for hydrogen production, thereby reducing greenhouse gas emissions.

Project activities will be conducted at existing facilities at Advanced Ionics, Inc. (Milwaukee, WI) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
