Proposed Action Title: Los Alamos National Laboratory -- Advanced Manufacturing of High-Entropy Alloys as Cost Effective Plasma Facing Components for Fusion Power Generation

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Los Alamos, New Mexico; Madison, Wisconsin; Clemson, South Carolina; Cambridge, Massachusetts

Proposed Action Description:

Funding will support the project team's small-scale research and development of novel tungsten (W)-based high-entropy alloys (HEA) with compositions and microstructures optimized for ideal performance in plasma-facing components (PFC). Specifically, the project team will (1) research, model, select, and test initial alloy compositions, (2) select a single alloy for testing and performance confirmation, and (3) fabricate components, test, and verify performance of W-HEA materials. If successful, this project will result in reliable PFCs made with W-HEAs that will reduce maintenance downtime in fusion power plants and increase first wall reliability during steady state and transient operation, making fusion power generation more cost-effective and economically predictable, ultimately reducing fossil fuel combustion and greenhouse gas emissions.

Project activities will be conducted at existing facilities at Los Alamos National Laboratory (Los Alamos, NM), University of Wisconsin-Madison (Madison, WI), Clemson University (Clemson, SC), and Massachusetts Institute of Technology (Cambridge, MA) designed for the applicable activities. The Prime Recipient has certified that (a) project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements, and (b) no modifications will be made to existing facilities to accommodate the proposed work.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
