Proposed Action Title: Oak Ridge National Laboratory and University of Tennessee-Knoxville -- Precipitation Strengthened Ni-Based Alloys for Liquid Salt Containment and Transport in Energy Systems

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Oak Ridge, Tennessee; Knoxville, Tennessee; Madison, Wisconsin

Proposed Action Description:

Funding will support the project team's small-scale research and development of an alloy with properties that can meet critical property requirements, such as operation at very high temperatures (750°C or higher), for use in liquid-fueled Molten Salt Reactors (MSR) and fluoride-salt cooled high temperature reactors (FHR). Specifically, the project team will (1) select and test alloy compositions, and (2) select a single alloy for further testing and fabrication of components for use in future market applications. If successful, this project will result in production of an alloy that will decrease risks associated with new alloy development and significantly accelerate the timeline for commercialization of the structural alloy for use in new, disruptive, high efficiency MSRs.

Project activities will be conducted at existing facilities at Oak Ridge National Laboratory (Oak Ridge, TN), University of Tennessee-Knoxville (Knoxville, TN), and University of Wisconsin-Madison (Madison, WI) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
