Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B3.6 Smallscale research and development, laboratory operations, and pilot projects Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

## Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to Arizona State University (ASU) to design, fabricate, and test ceramic-based structures capable of facilitating thermo-electrochemical production of hydrogen and carbon monoxide via solar energy.

Design, fabrication, and testing activities would occur at ASU laboratory facilities (Tempe, AZ). Fabrication of ceramic structures would use approximately 5kg of ceramic compounds. A flow reactor would be designed and fabricated to test the ceramic structures. Testing activities would involve characterizing and evaluating performance and durability of ceramic structures at different electrical inputs and temperatures. Fabrication and testing activities would involve conventional laboratory techniques and technologies. Additional award activities would include those of an intellectual, academic, and analytical nature. Such activities would support numerical modeling activities and the completion of a techno-economic analysis (TEA).

All facilities at ASU are preexisting purpose-built facilities for the type of work to be conducted for this award. Facility modifications would not be required. Award activities would involve the handling and use of hazardous materials, including ceramic powders, binding agents, solvents, and pressurized gases. All such handling and storage would occur within controlled laboratory settings at ASU and would follow existing policies and procedures for handling and disposal of these materials. Existing university health, safety, and environmental policies and procedures would be followed at all facilities, including: personnel training, proper personal protective equipment (PPE), engineering controls, monitoring, and internal assessments.

DOE has considered potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate adverse impacts on these resources.

### FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.
