Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B3.6 Smallscale research and development, laboratory operations, and pilot projects Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to Case Western Reserve University (CWRU) for the development and testing of an accelerated screening process for the induction and investigation of cellular failure modes. Accelerated aging of unencapsulated photovoltaic (PV) stacks and devices would be used in order to predict, understand, and mitigate PV device failure.

Proposed project activities including material characterization and data modeling would occur at CWRU (Cleveland, OH). University of Central Florida (UCF) (Orlando, FL) would characterize unencapsulated cell materials. Arizona State University (ASU) (Tempe, AZ) would fabricate PV cells and characterize cellular materials.

Proposed project activities would consist of laboratory scale research, including baseline characterization and durability testing of cells, destructive and non-destructive testing of unencapsulated cells, and predictive model creation. All proposed work would be completed in existing, purpose-built facilities.

This project would include potential hazards such as acetic acid and high temperatures. All materials would be handled in the lab, which follows strict university standards for handling chemical waste, including proper disposal in accordance with Federal, state, and local regulations. PV panels necessary for the proposed project activities would be disposed of properly.

There are no physical modifications to existing facilities, construction of new facilities, no ground disturbing activities, no changes in use of existing facilities, and no installation or deployment of outdoor equipment. There are no new permits or licenses required.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
