Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

B5.16 Solar photovoltaic systems

The installation, modification, operation, and removal of commercially available solar photovoltaic systems located on a building or other structure (such as rooftop, parking lot or facility, and mounted to signage, lighting, gates, or fences), or if located on land, generally comprising less than 10 acres within a previously disturbed or developed area. Covered actions would be in accordance with applicable requirements (such as local land use and zoning requirements) in the proposed project area and would incorporate appropriate control technologies and best management practices.

Rationale for determination:

The U.S. Department of Energy is proposing to provide funding to the Washington State Energy Office for roof mounted solar photovoltaic (PV) arrays on three buildings at the Lummi Indian Business Council Campus of the Lummi Reservation. The approximate size of the PV systems would include the Tribal Administration Building with a 285 kW DC array, the CARES building with a 134 kW DC array, and the Head Start Building with a 130 kW DC array. All PV systems would be grid connected with net metering.

The proposed arrays would consist of 1,036 solar modules, and 6 string inverters along with associated electrical wiring, conduit, racks, and ballasts. No structural improvements to any of roofs would be required. Additionally, no ground disturbance would be required. Some of the PV arrays would be visible from the public right-of-way, but all the buildings are less than 40 years old, so no effects to historic properties are anticipated.

Any changes to the project activities or locations are subject to additional NEPA review by DOE and are not authorized for Federal funding unless and until the Contracting Officer provides written authorization on those additions or modifications.
