Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

### Description:

A9 Information gathering, analysis, and dissemination Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B3.6 Smallscale research and development, laboratory operations, and pilot projects Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

#### Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to Advanced Materials Scientia LLC (AMS) for the fabrication, design, and testing of a recovery process for optically degraded Concentrating Solar Power (CSP) systems at bench scale.

All project activities would occur at AMS (Bothell, WA) and Heliogen (Pasadena, CA) over one Budget Period. AMS would carry out the fabrication and design, while Heliogen would carry out design and modification of the reactor, and scale-up testing.

Proposed project activities would include laboratory scale research, sample preparation, engineering design, recruiting an intern from an underrepresented group in science, technology, engineering, and mathematics (STEM), creating a bench-scale reactor, and carrying out testing. Testing would include evaluating temperature and atmospheric conditions, processing and operating time, hydrogen concentrations, solar absorptivity, and bench scale testing. Lastly, techno-economic analyses, capital expenditure, and operating expense calculations would be carried out.

This project would include the handling of potentially hazardous chemicals, including hydrogen gas. All materials would be handled in the lab, which follows strict university standards for handling chemical waste, including proper disposal in accordance with federal, state, and local regulations.

There are no physical modifications to existing facilities, no construction of new facilities, no ground disturbing activities, no changes in use of existing facilities, and no installation or deployment of outdoor equipment. There are no new permits or licenses required.

There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
