Proposed Action Title: North Carolina State University-- Microgrid Control/Coordination Co-Design (MicroC3)

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Raleigh, North Carolina; Nashville, Tennessee; Maywood, Illinois

Proposed Action Description:

Funding will support the project team's small-scale research and development of a modular resilient microgrid control integration platform. Specifically, the project team will (1) design and develop a microgrid optimization scenario and iterative algorithms for testing, (2) combine software and microgrid control algorithm for testing and validation, (3) develop and test final prototype system, and (4) deploy system for field testing and validation. If successful, this project will result in a hardware device with a robust, cyber-secure software platform and a library of microgrid control algorithms that can be automatically customized by the microgrid coordination/control co-design flow, which will improve distribution system reliability by reducing the load on the system under stress conditions.

Project activities will be conducted at existing facilities at North Carolina State University (Raleigh, NC), Vanderbilt University (Nashville, TN), and ComEd (Maywood, IL), designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
