

Proposed Action Title: Change Level Transmitter in the Defense waste Processing Facility

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Level Transmitter LT-2081 has an issue with its piping getting solidified causing inaccurate readings due to the Level Transmitter functionality. Thus the Level Transmitter is being changed to a contactless radar.
