Dear Mrs. Sweeney:

On December 16, 2016, the Office of Fossil Energy of the Department of Energy authorized Southern LNG Company, L.L.C. ("SLNG") to export liquefied natural gas ("LNG") to non-Free Trade Agreement countries for volumes equivalent to 130 Bcf/year in DOE/FE Order No. 3956 ("Non-FTA Order"). Condition I(i) to the Non-FTA Order requires that SLNG file "with the Office of Regulation and International Engagement a non-redacted copy of all executed long-term contracts associated with the long-term export of LNG as agent for other entities from the Elba Island Terminal" and either "(a) a redacted version of the contracts . . . or (b) major provisions of the contracts." On May 17, 2016, SLNG provided under seal the long-term contracts relating to the liquefaction and export services. Please find attached a summary form describing the long-term contracts associated with the long-term supply of natural gas to the Elba Island Terminal and for liquefaction and export services. This filing completes the requirements of Condition I.
