Request to Vacate Authorizations

Bear Head Energy Inc. (“Bear Head”) hereby requests that the Department of Energy (“DOE”) vacate Order No. 3681 (FTA) and Order No. 3770 (Non-FTA) issued in FE Docket No. 15-33-LNG on July 21, 2015 and February 5, 2016, respectively. Bear Head requests that the orders be vacated effective as of the date of DOE’s approval of this request.

Bear Head has decided as a commercial matter that it will no longer be pursuing the development of the natural gas liquefaction and export facility proposed in its application submitted in the referenced docket. Because exports of natural gas by pipeline to and re-export of natural gas as liquified natural gas from that proposed facility formed the basis of DOE’s authorizations granted in Order Nos. 3681 and 3770, Bear Head requests that the orders be vacated.

As noted in the Statement of Change in Control submitted to DOE on August 12, 2022, Bear Head is no longer affiliated with the co-authorization holder Bear Head LNG (USA), LLC (“Bear Head LNG (USA)”). Both Bear Head and Bear Head LNG (USA) were previously indirect subsidiaries of Liquefied Natural Gas Limited (“LNG Limited”), a formerly publicly-listed Australian company. Upon information and belief, Bear Head understands that Bear Head LNG (USA) may no longer exist due to the liquidation process for LNG Limited. However, if DOE determines that it is unable to vacate the orders in full as requested, Bear Head respectfully requests that DOE vacate the orders with respect to Bear Head only such that Bear Head holds no rights, interests, or liabilities thereunder.
