

Proposed Action Title: DWPF REDC Sellers Jet Removal

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

The Sellers Jet on the Nitric Acid Decontamination Feed Tank (NADFT) will be bypassed and replaced with a connection. The new connection will bring in Neutralized Well Water (NWW) (NWW is used throughout the Defense Waste Processing Facility and is not new) to help clean Remote Equipment Decontamination Cell (REDC) equipment. Valves and instrumentation that are no longer required will be removed.
