Proposed Action Description:

SRNL has been tasked with examining how various forms of mercury can migrate through the solvent extraction system at Salt Waste Processing Facility (SWPF). This involves non-radioactive solutions and compounds.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
