Proposed Action Description:

Gas phase Molybdenum Hexafluoride (MoF6), CO2 and water samples will be condensed on a diamond slide and studied using the Helios femtosecond transient absorption spectrometer in 999-2W lab 147. This activity is being performed as preliminary work for fundamental research advancing the understanding of hydrolysis kinetics for NNSA.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
