

Proposed Action Title: Synthesis of Polyoxometalate-based Photoanode Materials

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

SRNL will perform synthesis for the development of materials pertaining to photovoltaic devices such as electrolytes, (photo)sensitizers/anodes, and semiconductors. The scope of each synthesis will require various organic and inorganic reagents and the use of various synthetic techniques. There will be use of a Schlenk line for experiments that require air-free conditions.
