

Proposed Action Title: Install New Firestop System (A-DCF-H-00297) and Install Rm 16 N2 Heater Temperature Interlock (J-DCF-H-06233)

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

The proposed activities (PA's) are two design changes to building 233-H involving a new firewall penetration/ fire stop system and a new interlock installation for the hot and cold nitrogen heater vessel T199-500-34.60. No environmental impacts for electrical work, and minimum impacts for D&R of gypsum firewall and installation of intumescent firestop sealant.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
