Proposed Action Title: Stanford University - Open and Scalable Distributed Energy Resource Networks

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Stanford, Menlo Park, and El Nido, California

Proposed Action Description:

Funding will support the project team's small-scale, research and development activities to develop a powernet platform for distributed energy resources to enable energy resource sharing and real-time control of net loads, focusing on use in dairy farm and other farming facilities. Specifically, the project team will (1) refine an existing system design to reduce the cost of the proposed platform solution by removing unnecessary design components, (2) explore processes to accelerate product development, and (3) scale the solution for use at multiple sites. If successful, the powernet platform will require less energy for operation, thereby reducing combustion of fossil fuels and greenhouse gas emissions.

Project activities will be conducted at existing facilities at Stanford University (Stanford, CA), Stanford Linear Accelerator Center (SLAC), National Accelerator Laboratory, Grid Integration, Systems, and Mobility (GISMo) Lab (Menlo Park, CA), and Double Diamond Dairy Farm (El Nido, CA). Project tasks continue to fit within the class of actions identified under the DOE Categorical Exclusion identified below and do not involve any extraordinary circumstances that may affect the significance of the environmental effects of the project. This assessment was based on a review of the proposed scope of work and the potential environmental impact of the project. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
