Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to Rensselaer Polytechnic Institute (RPI) to produce and evaluate temperature resistant aluminum alloys. Four different alloys would be researched during three budget periods. This NEPA determination is applicable to all three budget periods.

Mechanical testing, microstructural characterization, constitutive modeling, and computer simulation would be completed at RPI (Troy, NY). Combinatorial arc synthesis, microstructural characterization, and phase analysis would be completed at Iowa State University (Ames, IA). Processing and microstructure characterization would be completed at Ames Laboratory (Ames, IA). Mechanical testing and computer modeling would be completed at General Electric Research (Niskayuna, NY). All testing, processing, and modeling would occur in laboratory settings.

All project activities would be completed in existing, purpose-built facilities. While award activities would involve the fabrication of metal alloys, there would be no modifications to or change in use of existing facilities. No new permits or licenses would be needed to perform award activities. Award activities would involve typical hazards associated with engineering laboratories, such as use and handling of electrical components, equipment, and machinery. Existing university and corporate health, safety, and environmental policies and procedures would be followed at all facilities, including: personnel training, proper personal protective equipment (PPE), engineering controls, monitoring, and internal assessments.

DOE has considered potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate adverse impacts on these resources.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.
