

Proposed Action Title: SRNL Stack Monitoring Upgrade

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

The project modifies Savannah River National Lab 773-A B&C and 791-A Sand Filter stacks to meet the ANSI N13.1 criterion for acceptable sampling and monitoring requirements to meet potential impact category (PIC) 1.
