Proposed Action Description:

DOE has asked that 12 moderator drums in L-Area be sampled to see if a customer can use them. The customer has certain specifications. If within specifications, L-Area may be asked to send the drums to the customer. And more drums may be sampled in the future.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
