Small-scale renewable energy research and development projects and small-scale pilot projects, provided that the projects are located within a previously disturbed or developed area. Covered actions would be in accordance with applicable requirements (such as local land use and zoning requirements) in the proposed project area and would incorporate appropriate control technologies and best management practices.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to administer Congressionally Directed Spending to implement a residential solar program in the Upper Peninsula of Michigan. The program would benefit low-income residents within the service area of the Alger Marquette Community Action Board. Prospective sites for both large-scale community solar projects and small-scale multifamily solar projects would be considered and analyzed for viability. Additionally, financial projections would be prepared based on current and anticipated funding sources.

Project activities would be limited to actions of an analytical and academic nature. No new installations of solar photovoltaics would occur. All project activities would be completed in existing, purpose-built facilities. No new permits or licenses would be needed to perform award activities. Existing government health, safety, and environmental policies and procedures would be followed at all facilities, including personnel training, proper personal protective equipment (PPE), engineering controls, monitoring, and internal assessments.

DOE has considered potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate adverse impacts on these resources.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
