A9 Information gathering, analysis, and dissemination	Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to the University of Texas at El Paso (UTEP) to develop reversible metal hydrides that could be dehydrogenated and recharged at low temperatures and pressures.

Award activities at UTEP would include the fabrication of various nanoscale magnesium boride powders via mechanically-activated self-propagating high-temperatures synthesis (MASHS). Once fabricated, powders would be characterized, assessed, and sent to the Sandia National Laboratory (SNL) for further analysis. A high-pressure hydrogen system would be used at SNL to conduct pressure-composition-temperature measurements and high-pressure hydrogenation of the fabricated powders. Award activities would occur entirely within existing, purpose-built facilities; therefore, no adverse impacts to sensitive resources are expected as a result of the proposed activities at any location. No change in the use, mission, or operation of existing facilities and locations would arise out of this effort.

Hazardous materials such as magnesium, boron powder, magnesium borides and magnesium borohydrides would be used, managed, stored, and disposed of in accordance with applicable federal, state, and local environmental regulations. All nanoscale materials would be handled using proper engineering controls until adhered to surface materials or dissolved in solvents. Existing university, and governmental health and safety policies and procedures would be followed, including employee training, proper protective equipment, engineering controls, monitoring, and internal assessments.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

DOE has made a final NEPA determination.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.
