Proposed Action Title: CorePower Magnetics Inc. -- Scaled In-Line Processing Facility for Permeability Engineered Nanocrystalline Magnetics

Program or Field Office: Advanced Research Projects Agency - Energy

Proposed Action Description:

Funding will support the project team's research and development of new inductors, transformers, and motors based on proprietary magnetic core technology to reduce their size and weight and improve efficiency, initially developed under the ARPA-E Solar Agile Delivery of Electrical Power Technology (ADEPT) program. Specifically, the project team will develop five such products for use in electric vehicles and the electrical grid. If successful, this project will develop high-power density magnetic components based on permeability engineered soft magnetics for use in electric vehicles and the power grid, reducing the need for rare earth elements, and reducing fossil fuel consumption and greenhouse gas emissions.

Project activities will be conducted at existing facilities at CorePower Magnetics Inc. (Pittsburgh, PA), John Deere (Fargo, ND), and North Carolina State University (Raleigh, NC) designed for the applicable activities. The Prime Recipient has certified that (a) project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements, and (b) no modifications will be made to existing facilities to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
