- In this Order, I adopt the attached Compromise Agreement entered into between the U.S.
 Department of Energy ("DOE") and Alliance Laundry Systems LLC ("Respondent"). The
 Compromise Agreement resolves the case initiated to pursue a civil penalty for distributing
 in commerce in the United States clothes washers that failed to meet an applicable energy
 conservation standard.
- DOE and Respondent have negotiated the terms of the Compromise Agreement that resolves this matter. A copy of the Compromise Agreement is attached hereto and incorporated by reference.
- 3. After reviewing the terms of the Compromise Agreement and evaluating the facts before me, I find that the public interest would be served by adopting the Compromise Agreement.
- 4. Based on the information in the case, I find that Respondent knowingly committed Prohibited Acts by distributing in commerce clothes washers that were not in conformity with the applicable energy conservation standard. *See* 42 U.S.C. § 6302; 10 C.F.R. §§ 429.102(a)(6), 430.32(g).
- Accordingly, pursuant to 10 C.F.R. § 429.120 and 42 U.S.C. § 6303, I HEREBY ASSESS a
 civil penalty of \$3,600,000 AND ORDER that the Compromise Agreement attached to this
 Order is adopted.
