Corpus Christi Liquefaction Stage III, LLC ("CCL Stage III") hereby submits¹ for filing under seal, a non-redacted copy of a Gas Supply Agreement entered into by CCL Stage III on May 29, 2019 with Apache Corporation ("Apache"). Under the Gas Supply Agreement, Apache will sell and CCL Stage III will purchase natural gas on a long-term basis. CCL Stage III intends to liquefy the natural gas purchased from Apache at the CCL Stage III LNG facilities.

CCL Stage III is also filing herewith a public summary of the major provisions of the agreement. This filing is being submitted in accordance with Department of Energy, Office of Fossil Energy ("DOE/FE") Order No. 4277² in FE Docket No. 18-78-LNG, including for the purpose of any future Non-FTA export authorization that may be granted in connection with such docket.
