**Re: In the Matter of Cheniere Marketing, LLC & Corpus Christi Liquefaction, LLC

Long-Term Supply Contracts**

Dear Ms. Sweeney:

On October 16, 2012, the U.S. Department of Energy, Office of Fossil Energy ("DOE/FE") issued an Order granting Cheniere Marketing, LLC's ("CMI") request under Section 3 of the Natural Gas Act ("NGA")<sup>1</sup> for long-term, multi-contract authorization to export up to the equivalent of 767 billion cubic feet ("Bcf") per year of liquefied natural gas ("LNG") from the Corpus Christi Liquefaction Project in Corpus Christi, Texas ("Liquefaction Project") to nations with which the United States has entered, or in the future enters, into a free trade agreement ("FTA") requiring the national treatment for trade in natural gas.<sup>2</sup> On October 29, 2014, DOE/FE issued Order No. 3164-A authorizing the addition of Corpus Christi Liquefaction, LLC ("CCL") as an authorization holder under DOE/FE Order No. 3164.<sup>3</sup>

On May 12, 2015, DOE/FE issued a Final Opinion and Order granting CMI and CCL's application under NGA Section 3 for long-term, multi-contract authorization to export up to the equivalent of 767 Bcf per year of LNG from the Liquefaction Project to nations with which the United States has not entered into an FTA requiring the national treatment for trade in natural gas.<sup>4</sup>

In DOE/FE Order Nos. 3638 & 3164, DOE/FE directed CMI and CCL to file with DOE/FE's Office of Natural Gas Regulatory Activities all executed "long-term contracts associated with the long-

term supply”<sup>5</sup> of natural gas to the Liquefaction Project. In this regard, DOE/FE has given CMI and CCL the option to file long-term contracts under seal along with a public summary of the major provisions of the contracts.<sup>6</sup>

CCL has entered into North American Energy Standards Board (“NAESB”) Base Contracts for Sale and Purchase of Natural Gas (“Base Contracts”) with each of the following sellers:

1. Houston Pipe Line Company, LP
2. Cimarex Energy Co.
3. Pioneer Natural Resources USA, Inc.
4. Targa Gas Marketing, LLC
5. Chief Oil & Gas LLC
6. Apache Corporation
7. Wells Fargo Commodities, LLC
8. Shell Energy North America (US), L.P.

Pursuant to the terms of each of the NAESB Base Contracts, the associated Transaction Confirmations (“Confirmations”) document transactions whereby each of the sellers, respectively, agree to sell to CCL a fixed quantity of natural gas on a firm, long-term basis. CCL intends to liquefy the natural gas secured under the Confirmations for export from the Liquefaction Project, pursuant to the authorizations granted in the above-referenced proceedings.

The NAESB Base Contracts and Confirmations contain commercially sensitive information, and are being filed under seal.<sup>7</sup> CCL respectfully requests that the Base Contracts and Confirmations be granted privileged and confidential treatment. A summary of the major provisions that are not deemed confidential is set forth in Appendix A hereto.
