Long-Term Supply Contracts**

Dear Ms. Sweeney:

Cheniere Marketing, LLC (“Cheniere Marketing”) and Corpus Christi Liquefaction, LLC (“CCL”) hereby notify the Department of Energy, Office of Fossil Energy (“DOE/FE”) of a change in counterparty to a previously submitted long-term contract associated with the long-term supply of natural gas to the Corpus Christi Liquefaction Project in Corpus Christi, Texas. The Transaction Confirmation dated November 6, 2017 (the “Confirmation”), under the NAESB Base Contract for Sale and Purchase of Natural Gas dated December 7, 2016 (the “Apache NAESB”) between CCL and Apache Corporation (“Apache”), has been partially assigned by Apache to Kinder Morgan Tejas Pipeline, LLC (“KMTP”) effective as of November 11, 2020. The partial assignment of the Confirmation was effected via the execution of two new confirmations: (i) one between CCL and Apache to amend and restate the Confirmation by reducing the contract quantity being effectively assigned by Apache to KMTP (the “Apache Confirmation”), and (ii) one between CCL and KMTP to document the contract quantity of Gas being acquired by KMTP from Apache (the “KMTP Confirmation”).

Upon effectiveness of the Assignment, the Apache Confirmation will be governed by the Apache NAESB, and the KMTP Confirmation will be governed by the NAESB Base Contract for Sale and Purchase of Natural Gas dated June 1, 2020 (the “KMTP NAESB”) between CCL and KMTP.

Cheniere Marketing and CCL hereby submit for filing under seal¹, non-redacted copies of the Apache Confirmation, Apache NAESB, KMTP Confirmation, and KMTP NAESB. This filing is being submitted in accordance with DOE/FE Order No. 3164, as amended by DOE/FE Order

No. 3164-A,² DOE/FE Order No. 3638,³ and DOE/FE Order No. 4519,⁴. Cheniere Marketing and CCL hereby request confidential treatment of the Apache Confirmation, the Apache NAESB, the KMTP Confirmation, and the KMTP NAESB filed herewith, as they contain commercially sensitive information.
