Cheniere Marketing, LLC (“Cheniere Marketing”) and Corpus Christi Liquefaction, LLC (“CCL”) hereby submit¹ for filing under seal, a non-redacted copy of the NAESB Base Contract for Sale and Purchase of Natural Gas (as may have been amended from time to time, the “Base Contract”) and the Transaction Confirmation (“Confirmation”), entered into by CCL on September 30, 2015 and April 23, 2021 (respectively) with Castleton Commodities Merchant Trading L.P. (“Counterparty”). Under the Base Contract and Confirmation, Counterparty will sell and CCL will purchase natural gas on a long-term basis. CCL intends to liquefy the natural gas purchased from Counterparty at the Corpus Christi Liquefaction Project.

Cheniere Marketing and CCL are also filing herewith a public summary of the major provisions of the Base Contract and Confirmation. This filing is being submitted in accordance with Department of Energy, Office of Fossil Energy (“DOE/FE”) Order Nos. 3164, 3638 and 4519 (each as may have been amended).² Cheniere Marketing and CCL hereby request confidential treatment of the Base Contract and Confirmation filed herewith, as they contain commercially sensitive information.

Similarly, in respect of any day, the Buyer is obliged to take a specified quantity of gas, or compensate the Seller if not taken, unless otherwise excused under the contract.
