Description:

Rationale for determination:

The Department of Energy (DOE) is proposing to provide funding to the National Association of State Energy Officials (NASEO). Proposed efforts would include technical assistance to the State and Territory Energy Offices (hereinafter "State Energy Offices"), as well as provide communication and coordination assistance between DOE and the State Energy Offices. NASEO would also focus on supporting the delivery of the U.S. State Energy Program and the State Energy Office's energy efficiency and renewable energy activities.

Specifically, NASEO would work with DOE's Energy Efficiency and Renewable Energy's Weatherization and Intergovernmental Programs Office (WIP) to provide guidance, analysis, and enhanced coordination between WIP and the State Energy Offices in the delivery of energy efficiency and renewable energy programs. Additionally, NASEO would provide comprehensive energy planning support as well as offer trainings and other instructional mechanisms across a variety of mediums to support development and implementation of effective energy efficiency and renewable energy programs and initiatives within the State Energy Offices. Lastly, NASEO would identify financing mechanisms and provide assistance to support energy equity and affordability and enhance partnerships to support development and adoption of energy technology.
